Board discussed how to fill position, GRAC position needs to be filled as well Motion to approve David Dailey to assume the position as the GRAC Board chair Parent / Treas. Clerk Dailey.
- E. Alcona County Agreement- Treas. P. Dailey reported her cost, Assessor Nancy Schwickert added some information, Treas. P. Dailey explained that it is more a schedule of fees than an agreement because we do not use the county for all of the services, Clerk Dailey will ask the county
