Supervisor Major attended a Board of Commissioners meeting about the Payment in lieu of taxes (PILT) disbursement. Clarification of the PILT fund was given by Sheila Scott.

Clerk D. Dailey- received a dividend check for \$705.30 from Michigan Township Participating plan from 2013/2014, 2011/2012, & 2012/2013. TruGreen mosquito defense mailing received. Consumers energy will be changing mercury vapor lights to high pressure sodium lights or LED lights, the costs and savings were talked about, will add this to the agenda for next month.

Trustee Parent- received a letter opposing the Verizon tower placement and will give a copy to all board members. Received a phone call about pontoon boats parking on private easement, told them to call the Sherriff.

- b. 2017 Tax rate request- discussion about allocations, in 1969 .3 mil was taken from the Townships and given to the county by the Supervisors which later became County commissioners. Additionally the Headlee Amendment reduced the Township's millage monies further. Clerk D. Dailey will look into getting some of that back.
- 12) Public comment- Adult softball league questioned by a resident, D. Dailey explained that GRAC would like to talk to him more. Resident explained that a break in occurred and his daughter was injured a week previous and when authorities were called but nothing has come of it. The same resident near him is burning rubbish and living without water, the board needs to try to do more. Supervisor Major explained that the Township board does not have the authority that the law enforcement or the health department has and to call them. Resident added that they called the Environmental Protection Agency. Resident is dumping raw sewage on US 23, some discussion. D. Dailey brought up a neighborhood watch, or Special Deputys more discussion will follow. Chief Franks questioned and ordinance change for the Fire Department Kalitta had an appreciation lunch that was very nice. Resident asked about Township officials that do not all have email addresses listed on the website, some members were able to add email addresses to be published.
