1) Call to order

- a) After recessing the regular Township Board meeting at 7:03 pm Supervisor Major called to order the Fiscal Year (FY) 2019-2020 Budget Public Hearing at 7:04 pm on March 12, 2019 at the Greenbush Township Hall.

2) Roll call

- a) Deputy Clerk Story conducted a roll call. The following were present: Supervisor Major, Trustee Parent, and Trustee Scott. The following were absent: Clerk Dailey and Treasurer Dailey. Quorum present.

Supervisor major read the following statement aloud: "NOW, THEREFORE BE IT RESOLVED THAT: The Township of Greenbush will levy the maximum authorized millage rates allowed for tax year 2019."

Estimated FY 2019-2020 General Fund revenues are equal to estimated expenditures of \$222,322. Estimated FY 2019-2020 Fire Fund revenues are equal to estimated expenditures of \$50,375.
